1. What is this course about?

1.1. Description

This course introduces you to a range of novels created for children and young adults. Drawing upon genres such as realism, fantasy, dystopian and speculative narratives, you will be encouraged to write original and innovative narratives for a youth audience and gain an appreciation for the elements that make for successful and impactful children's and young adult literature. You will also enrich your creative practice through critical reflection.

10.1. Assessment: Academic Integrity

10.2. Assessment: Additional Requirements

10.3. Assessment: Submission penalties

Late submission of assessment tasks may be penalised at the following maximum rate:

- 5% (of the assessment task's identified value) per day for the first two days from the date identified as the due date for the assessment task.

- 10% (of the assessment task's identified value) for the third day - 20% (of the assessment task's identified value) for the fourth day and subsequent days up to and including seven days from the date identified as the due date for the assessment task.

- A result of zero is awarded for an assessment task submitted after seven days from the date identified as the due date for the assessment task. Weekdays and weekends are included in the calculation of days late. To request an extension you must contact your course coordinator to negotiate an outcome.
